Awareness Training Program for girls on good touch and bad touch

Location: Abhinav Public School

Objective: The primary objective of the awareness training program was to educate and empower girls regarding good touch and bad touch, instilling in them the importance of body ownership and consent.

Principal Ashwini Pansare conducted the training for the girls.

Key Points Covered:

Body Ownership: The girls were taught that they have control over their bodies and have the right to deny any physical touch that makes them uncomfortable. They were encouraged to say no to unwanted touches, such as handshakes, hugs, or photographs, without feeling obligated.

Good Touch vs. Bad Touch: A clear distinction was made between good touches (caring, safe, and comfortable) and bad touches (uncomfortable, scary, or inappropriate). Examples were provided to help the girls understand the difference.

Use of Appropriate Terminology: Correct terminology for private body parts was used to emphasize their importance and to ensure effective communication about sensitive topics.

Swimsuit Rule: The concept of the swimsuit rule was introduced, explaining that areas covered by underwear or a swimsuit are private and should not be touched or seen by anyone else.

Empowering Children to Say No: The girls were encouraged to assertively say no to any touch they do not like, even if it comes from family members or friends.

Reporting Uncomfortable Touches: Emphasis was placed on the importance of reporting any uncomfortable or hurtful touches to a trusted adult, such as parents, teachers, or other responsible individuals.

Being Body Bosses: Starting from an early age, children were taught that they are in charge of their bodies and have the right to speak up if someone is hurting them or making them uncomfortable.

Conclusion: The awareness training program at Abhinav Public School aimed to equip girls with the knowledge and confidence to assert their boundaries, recognize inappropriate behaviour, and seek help when needed. By promoting body ownership and consent, the program contributed to the development of healthy mental health and personal safety among the student's awareness Training Program at Abhinav.
